**Division C of Public Law 113-76, Department of Defense Appropriations Act, 2014 (January 17, 2014)**

**Reimbursement to Pakistan \$236,144,095**

The Government of Pakistan was reimbursed for expenses incurred in providing critical military support to U.S. military operations in connection with Operation ENDURING FREEDOM by conducting military operations against Al Qaeda and Taliban forces operating in the tribal areas adjacent to Afghanistan and to conduct maritime interdiction operations to prevent terrorist infiltration. This \$236.1 million payment partially covers the total \$336.8 million paid for the period of support from April 2014 through June 2014. A balance of \$100.7 million for this period of support was covered by funds from the DoD Appropriations Act, 2015.

**Reimbursement to Hungary \$765,154**

The Government of Hungary was reimbursed for expenses incurred in providing critical military support to U.S. military operations in connection with Operation ENDURING FREEDOM by filling critical shortfalls in force protection forces at Kabul Afghanistan International Airport, enabling U.S. forces to be reassigned to other critical mission areas within Afghanistan. This payment covers the period of support from January 2013 through September 2013.

**Division C of Public Law 113-235, Department of Defense Appropriations Act, 2015 (December 16, 2014)**

**Reimbursement to Pakistan \$100,720,171**

The Government of Pakistan was reimbursed for expenses incurred in providing critical military support to U.S. military operations in connection with Operation FREEDOM'S SENTINEL in Afghanistan by conducting military operations against Al Qaeda and Taliban forces operating in the tribal areas adjacent to Afghanistan and to conduct maritime interdiction operations to prevent terrorist infiltration. This \$100.7 million payment partially covers the total \$336.8 million paid for the period of support from April 2014 through June 2014. A balance of \$236.1 million for this period of support was covered by funds from the DoD Appropriations Act, 2014.

This payment covers the period of support from January 2014 through December 2014.

The Government of Jordan was reimbursed, using amounts appropriated for Coalition Support Funds, for expenses incurred in supporting and maintaining efforts of the armed forces of Jordan to increase security and sustain increased security along the border between Jordan and Syria under the authority of section 1207 of the National Defense Authorization Act for Fiscal Year 2014 (P.L. 113-66).
